LOVE DOES PARADE

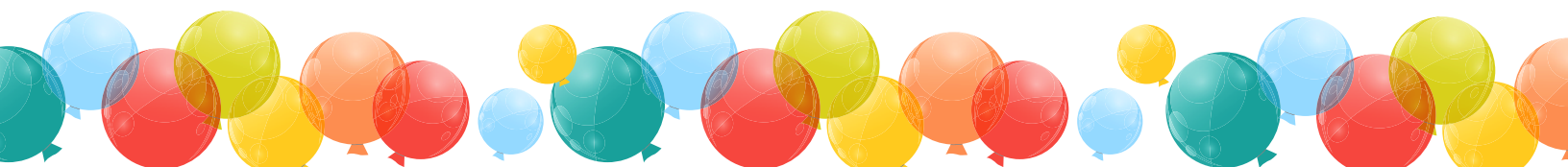

Sample language for legacy giving in estate planning:

Specific Amount Bequest

Percentage Bequest

The Trustee shall ____ (___%) of the remaining assets of the trust estate, outright and free of trust to the LOVE DOES PARADE (EIN: 82-3110971) or its successor, currently located at PO Box 60370, San Diego, California 92166, to be used for the general purpose of such organization at the discretion of its Board of Directors.

Bequests of accounts with beneficiary designations

Another simple and straightforward way you can provide a gift to the Love Does Parade is by naming the nonprofit as a beneficiary on any of your bank accounts or brokerage accounts. This can be accomplished by placing a “payable on death” (POD) on your bank account or “transfer on death” (TOD) designation on your brokerage or investment account. This allows for the you to retain control of the accounts during your lifetime and then a gift to be made after your lifetime. Please talk to your banking or brokerage institution about how to place one of these distinctions on your account if you feel this is a good option for you, your family, and your legacy.

Charitable remainder trust

Charitable remainder trusts are an estate planning tool that allows an income stream for the donor or other beneficiaries with the remainder of the assets donated to a particular charity or charities. There are different types of charitable remainder trusts, so if you and your advisors determine that it is an appropriate tool for you, your family, and your goals, then we would be honored to have Love Does Parade as a remainder beneficiary.
